**Sub:** Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Satish Kr. Sah (41 Yrs) S/o- Suresh Ch. Sah of Barabazar Joynagarpara, PS- Barabazar, Dist- Purulia, along with Memo of Arrest, seizure List & seized articles (i) One packet of KALIPATKA containing 10000 flash (ii) One packet of KALIPATKA containing 3000 flash manufactured by Sunlight Fireworks Industries, Sivakasi. I beg to submit that on 30.10.2020 as per source information & direction of I.C Barabazar PS; myself along with force had been to Barabazar Jaynagarpara to work out the Information regarding selling of fire crackers.

Accordingly, myself along with force namely C/- 98 Anil Ch. Orang & C/- 357 Gopal Biswas with Govt. vehicle bearing registration No- WB 26K 5475 reached at Barabazar Joynagarpara at 12.15 hrs and found that one person is selling and dealing with fire crackers (Prohibited articles) and seen the Police party tried to fled away. Somehow we managed to apprehend him and on being asked his identity, he disclosed his identity as Satish Kr. Sah (41 Yrs) S/o- Suresh Ch. Sah of Barabazar Joynagarpara, PS- Barabazar, Dist- Purulia. I asked him to produce valid paper / license in respect of selling / keeping / dealing with fire crackers (prohibited articles). He failed to produce any papers or license and cannot gives any satisfactory answer and confesses his guilt.

Accordingly, I seized (i) One packet of KALIPATKA containing 10000 flash (ii) One packet of KALIPATKA containing 3000 flash manufactured by Sunlight Fireworks Industries, Sivakasi. I marked the Alamat as Exhibit- A; from the possession of the above noted accused person. The seizure list was prepared at P.O and duly signed by detained persons and witnesses. After that I arrested him by issuing memo of arrest. Then myself along with force, seized articles and all relevant papers and accused persons left for PS.

On arrival at PS I prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer for starting a case under proper section of law against the accused persons
