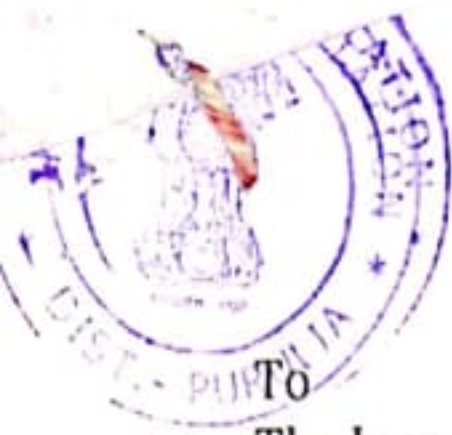

Sir,

I, SI Mithun Kr. Sar of Jhalda P.S. returned to PS with force and lodged this complaint against 1. Naresh Gorait (29) S/O Kalipada Gorait of vill- Patrahatu, Tola-Laldih, PS-Kotshila, Dist-Purulia, 2. Sanjoy Goswami (24) S/O Bibharam Goswami (24) of vill- Karrior, PS-Kotshila, Dist-Purulia, 3. Sadai Mura (22) S/O Bhukhal Mura of vill- Karrior, PS-Kotshila, Dist-Purulia, 4. Sishupal Kumar (27) S/O Prasadi Kumar of vill- Birudih, PS-Jhalda, Dist-Purulia, 5. Bharat Mahato (42) S/O Lt. Bijoy Mahato of vill- Chotto Ganta, PS-Jhalda, Dist-Purulia, 6. Chandan Mahato (21) S/O Jhamadar Mahato of vill- Olgara, PS-Jhalda, Dist-Purulia, 7. Paresh Rajowar (25) S/O Lt. Sikandar of Jhaldda Bagandih, Ward No-VII, PS-Jhalda, Dist-Purulia to the effect that today i.e. on 17/10/2020 myself along with force were engaged on Spl. Mobile duty at Jhalda PS area. During Spl. mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. During Spl. mobile duty at 14:05 hrs. myself along with force went to Birsamore, PS-Jhalda, Dist-Purulia and checked and detained above noted accd. persons as they did not wear mask on their face and moving casually. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. So, there is every reason to believe that the accd. persons came out from their home and moving aimlessly or making fun and they did not come for emergency purpose. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 31.08.2020 and Order of Govt. of West Bengal vide memo no-283-CS/2020 dated-21/07/2020. Therefore, they disobeyed Govt. order. I arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodged against above noted 10 (Ten) arrested accd. persons as they disobeyed Govt. order regarding epidemic COVID-19 U/S 188 IPC and 51(b) of Disaster Management Act, 2005 and arrange for investigation.
