Sir,

In producing here with one arrested accd. person namely Raju Saw (39) S/O Kinkar Saw of Jhalda Anandabazar, Ward No-02, PS-Jhalda, Dist-Purulia brought under seizure (i) One bottle Officer's Choice (Deluxe Whisky) approx 400 ml. (ii) One bottle MC Dowell's No-01, RUM, approx 550 ml. (iii) One bottle Magic Moments Grain Vodka approx 600 ml. (iv) One Plastic Jarican containing 15 Ltrs. ID liquor. I do hereby lodged this written complain to the effect that on- 10/10/2020 at 20:05 hrs. I received telephonic source information that one person selling Foreign Liquor and ID Liquor from his hotel styled as "Bishnu Hotel" situated at Birsamore on Jhalda Baghmundi Road, PS-Jhalda, Dist-Purulia. I informed the matter to I/C Jhalda P.S over phone and as per his direction myself SI Dibakar Kuiry along with C/571 Md. Hasib Khan C/696- Gorapada Pal, NVF/778 Samir Mahato and NVF/039 Lalit Kishor Mahato, vide C.C No. 2870/20 dtd- 10/10/20 left for Bishnu Hotel at Birsamore on Jhalda Baghmundi Road, PS-Jhalda, Dist-Purulia to work out the information. We reached at Bishnu Hotel at Birsamore on Jhalda Baghmundi Road, PS-Jhalda, Dist-Purulia at about 20:45 hours and held raid at "Bishnu Hotel" and found that the accused person namely Raju Saw (39) S/O Kinkar Saw of Jhalda Anandabazar, Ward No-02, PS-Jhalda, Dist-Purulia, owner of the hotel is selling Foreign Liquor and ID Liquor from his hotel. Seeing the Police party the buyers are fled away. On demand he could not produce any valid documents/license in favour of selling the same. Accordingly I seized (i) One bottle Officer's Choice (Deluxe Whisky) approx 400 ml. (ii) One bottle MC Dowell's No-01, RUM, approx 550 ml. (iii) One bottle Magic Moments Grain Vodka approx 600 ml. (iv) One Plastic Jarican containing 15 Ltrs. ID liquor under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but found none.

Accordingly I arrested accd. Raju Saw (39) S/O Kinkar Saw of Jhalda Anandabazar, Ward No-02, PS-Jhalda, Dist-Purulia maintaining all formalities after issuing arrest memo. On integration he confessed that he is selling the Foreign Liquor and ID Liquor to the people in lieu of money. So he committed offence punishable U/S - 46 (A) (c) of B.E. Act. 1909.

On return to P.S. along with accd. person and all seized articles. Put the accd. person in the Lock Up after maintaining all formalities and seized articles kept in P.S. Malkhana and I do here by submitting this written complaint to start a case against Raju Saw (39) S/O Kinkar Saw of Jhalda Anandabazar, Ward No-02, PS-Jhalda, Dist-Purulia under proper section of law.
