Sir,

With due respect I SI Susanta Kr Pathak of Joypur PS, beg to submit before you that on 10/10/2020 at about 10:05 hrs while myself along with force were conducted special raid against non-wearing of mask at Joypur Bazar on Purulia-Ranchi road as per order of my superior vide Joypur PS GDE No-490 Date-10/10/2020 & CC No-4361/20 Date-10/10/2020 and found the following persons, were roaming at Joypur Bazar without any face cover / mask. In spite of several request & reminder they refuse to wear mask and return back from public place to prevent the spread Covid-19 pandemic situation. I asked them to wear mask or leave the bazaar but they did not comply my request & roaming in the Bazar without face cover / mask. Myself along with accompanied force detained them at Joypur Bazar near Atakol more. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this respect DM Purulia promulgated an order for compulsory wearing of face cover / mask at Purulia District vide Memo No-189/Health Dated-25/09/2020. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons arrested on 10/10/2020 from 11:45 hrs to 12:35 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.
