This is for your kind information  
the undersigned person belongs to the Kashifm  
Raj Dynasty who is son of Rajkumar Nakshwan  
Devi. Yesterday, that is 25/10/2020 at about 9:15pm

all at sudden was assaulted by two persons

The said persons are unsocial and dangerous and desperate also who do not have any respect to law and Doctor.

It is pertinent to note that the said person continues to threaten the undersigned person at any opportune person can kill him.

The said persons incessantly are trying to break the peace of Rajbari along with its tranquility where Rajkumari Nekeswari Devi resides at the age of 72.

Hence you are hereby requested to please take legal action against the above named person according to law to restore the glory of Rajbari and provide safeguard to it.
