Sir,

In producing herewith one Tractor having Registration No. WB55A-1112 attached with Trolly loaded with sand. The fact of the case in brief is that on 17/10/2020 I along with C/1333 Dilip Kr. Mahata and NVF/826 Ramcharan Mahata all of Kenda PS were on day mobile duty. During mobile duty on 17/10/20 at about 14.35 hrs. while we reached near Bansa village found that the above noted tractor coming from Maheshpur side towards Bansa village. On seeing the Police party the driver of the said tractor stopped the tractor in a distance and fled away after keeping the tractor near at Bansa village. We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor having Registration No. WB55A-1112 attached with Trolly loaded with sand without any number plate under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source and brought the said tractor to Kenda PS. So it reason to belief that driver & owner of the said tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Registration No. WB55A-1112 attached with Trolly loaded with sand.
