Kakil Karmakar of Vill- Kuchung , PS- Kenda, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 09/10/2020, as per direction while I along with C/1255 Ajoy Kr. Bouri & C/1157 Khaja Sams Basar both of Kenda PS engaged in special mobile duty at Kenda PS area. While we reached at Kenda Sardardih more at about 19:05 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule.

Therefore, I pray that a specific case may kindly be start against (i) Laxmikanta Mahato (35), S/o- Sripati Mahato of Vill- Kuchung , PS- Kenda, Dist- Purulia (ii) Gaju Karmakar (45), S/o- Lt. Kakil Karmakar of Vill- Kuchung , PS- Kenda, Dist- Purulia as per proper section of law.
