While we reached at Kenda Thana more at about 16:15 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule.

Therefore, I pray that a specific case may kindly be start against (i) Saddam Ansari (27), S/o- Monjur Ali Ansari of Vill- Hijoli , PS- Hura, Dist- Purulia (ii) Baidyanath Hembram (27), S/o- Pelu Hembram of Vill- Doldoli(Majhidih) , PS- Hura, Dist- Purulia (iii) Mothan Mahato (45), S/o- Chutulal Mahato of Vill- Banjora , PS- Barabazar, Dist- Purulia (iv) Tarapada Murmu (58), S/o- Lt. Rangtu Murmu of Vill- Hatikundar , PS- Hura, Dist- Purulia as per proper section of law.
