In producing herewith one accd. person namely Narendra Nath Kumar @ Gohali Kumar (48 Yrs) S/O Lt. Thakurdas Kumar of vill. Gorayatanr, P.S. – Kotshila Dist – Purulia with seizure of 09 (Nine) sealed bottles of country spirit “DILKHUSH” containing 600ml each bottle.

I beg to submit that today (23.10.2020) in between 17.25 hrs to 17.55 hrs a raid was conducted in the house of Narendra Nath Kumar @ Gohali Kumar (48 Yrs) S/O Lt. Thakurdas Kumar of vill. Gorayatanr, P.S. – Kotshila Dist – Purulia. In course of my mobile duty on acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling country spirit which was kept in house. On demand he failed to produce any valid document of concern authority in respect of selling/keeping of liquor of the house. He was committing such illegal act in presence of police person. As such he was arrested u/s 67 B.E Act and also seized 09 (Nine) sealed bottles country spirit “DILKHUSH” containing 600ml each bottle, which was seized under proper seizure list in presence of witnesses duly signed by the accused person u/s- 67 B.E. Act which enclose herewith out of 09 (Nine) sealed bottles one (600ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest was duly notified to the accd. Person and issuing arrest memo u/s- 50 Cr.P.C. and a copy of the arrest memo handed over to the accd. Person .

The above noted arrested accd. namely Narendra Nath Kumar @ Gohali Kumar (48 Yrs) S/O Lt. Thakurdas Kumar of vill. Gorayatanr, P.S. – Kotshila Dist – Purulia, committed offence u/s- 46A (c) BE Act 1909 for un- authorized possession and selling of country spirit from his house.

It may note here that during raid (01) ASI Jashushri Bhattacharya (02) C-427 Tapan Kr. Sahis & (03) JC/1349 Firoj Ansary accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46A (c) B.E. Act. 1909 may kindly be started against Narendra Nath Kumar @ Gohali Kumar (48 Yrs) S/O Lt. Thakurdas Kumar of vill. Gorayatanr, P.S. – Kotshila Dist – Purulia
