Most respectfully begs to submit as follows:-





Khedadih within P.S.Kotshila, Dist. Purulia &x and within the jurisdiction of your Honour's Court.

- 2. That the complainant/petitioner happens to be the uncle of the victim lady Chhabi Kumar D/O Sristidhar Kumar.
- 3. That the accused No.1 Krishna Kumar married for the second time to said Chhabi Kumar, the niece of the complainant/petitioner at Chirka Temple within P.S.Purulia (M), Dist.Purulia.
- 4. That after solemnisation of marriage at Chirka Temple the accused No.1 had taken said Chhabi Kumar, the niece of of the complainant to his house at Village-Adardih and the accused No.1 lived with said Chhabi Kumar as husband and wife.
- 5. That the accused No.1 Krishna Kumar in connivance with his first wife Gulia Kumar and his daughter Lakshimani Kumar started physical and mental torture upon said Chhabi Kumar. They did not provide sufficient food, cloths and daily necessities to said Chhabi Kumar, the niece of the complainant and they did not give shelter to her to reside in her matmimonial house at Village- Adardih. The accused Nos.1 to 3 used to assult the said niece of the complainant by fist and blows as well as by lathi and oftenly drove from her matrimonial house.
 - 6. That on the date of incident i.e.on 25-07-2020 at about 10.00 P.M. the accused Nos.1,2 and 3 in connivance with each other throatled to the said niece of the complainant and killed her. That the said MR niece of the complainant was throatled to death by the said accused Nos.1,2 and 3.
 - 7. That this brutal killing was caused by the aforesaid accuseds Krishna Kumar, Gulia Kumar and Lakshimani Kumar about which the complainant/petitioner got information at about 12.00 P.M. and immediately after getting the



death information of his said niece he informed the matter to the police of Kotshila P.S. on the date of incident and that was entered into the General Diary and the police of Kotshila P.S. without starting a specific case of murder only started Kotshila P.S. U/D Case No. 07/2020 dated 26-07-2020.

- 8. That inquest of the dead body of Chhabi Kumar was held by the police of Kotshila P.S. and dead body was challaned to Deben Mahato Govt.Medical College and Hospital, Purulia for post mortem wherein post mortem was held on 26-07-2020 and after post mortem the dead body of Chhabi Kumar handed over to the complainant/petitioner.
- 9. That after hearing the death information of said Chhabi Kumar, her father Sristidhar Kumar became senseless and mentally shocked and he was not in a position to lodge complaint to the police against the aforesaid accuseds and for that the complainant informed the matter to the O.C.Kotshila P.S.But the O.C.Kotshila P.S.refused to take the written complaint of the complainant/petitioner. Hence the complainant has no other alternative but to lodge the written complaint to the S.P. Purulia on 24-08+2020 for taking immediate action against the aforesaid accuseds.
- 10. That delay was caused for unavoidable circumstances.

Hence it is prayed that your Honour may kindly be pleased to admit this criminal Misc. Petition and send it to the O.C.Kotshila P.S. for starting a specific case against the aforesaid accuseds after teating this petition as an F.I.R.U/S 156(3) of Cr.P.C.

For this shall ever pray.
