The humble petition on behalf of complainant

Most respectfully begs to shweth as follows:

- 1. That your complainant is the legally married wife of the accused No.1 and said marriage was solemnized on 11.12.2017 according to Hindu Rites and Customs at the house of the parents of the complainant.
- 2. That thereafter your complainant was brought to the matrimonial home of the complainant and started to live there along with the accused no.1 as husband and wife and the marriage was consummated and out of the said wedlock there is no issue.
- 3. That the accused No.1 is the husband of your complainant, the accused No.2 is the father-in-law of your complainant, the accused no.3 is the mother-in-law of the complainant and accused no. 4 brother-in-law of the complainant.
- 4. That at the time of marriage of your complainant, the complainant's father gave cash of Rs.1,30,000/-, approx 2 bhories gold ornaments, sufficient Kansa, Steel and bronze Utensils, One Palank, one Almirah, one T.V., Dressing Table one Trunk, one Gas Oven, one Fan and garments as per the demand of the accused persons.
- 5. That after passing of few days the accused persons demanded and pressurized your complainant to bring Rs.50,000/- more from her father and on the incapability on the part of your complainants poor father of fulfilling such illegal demand of the accused persons, the accused no. 1 along with other accused persons started mental and physical torture upon your complainant and hoping for better days your complainant kept mum.



- 6. That regularly the accused no 1 came home in a drunken condition and started beating your complainant mercilessly and your complainant cried for help but nobody came to rescue her.
- 7. That the father of your complainant is a poor man and unable to fulfill the above said demand of the accused no.1 and his other family members as such all the accused persons started to inflict inhuman physical and mental torture upon your complainant.
- 8. That the local peoples and family friends tried to settle the dispute between the parties but of no fruitful result came out. After passing of few days the accused persons again started to inflict mental and physical torture upon your complainant and. when the complainant expressed her desire to visit her parents house the accused no.1 accompanied with the accused no.2 assaulted your complainant mercilessly with feast and blows Later the accused persons forcefully drove the complainant out from her matrimonial house and finding no other alternative your complainant informed the matter to the witness No.2 and the witness no. 2 & 3 came and took the complainant to her parent's house.
- 9. That passing of few days on at her parents house the petitioner went to her matrimonial house along with her family members on 20.05.2018 and the accused persons the complainant started to assault her with filthy languages and also assaulted her physically and caught hold the complainant by her hair dragged her out of her matrimonial house and drove her and her parents out of their house keeping all the valuable articles under their custody.
- 10. That on 17.08.2018 the accused no. 1, 2, 3 & 4 came to the house of the complainant and threatened your complainant that if she file any case or lodge any complain against the accused persons then the accused persons shall kill the



complainant and when your complainant raised protest against the illegal activities of the accused persons the accused persons became furious and assaulted her mercilessly with fist and blows and as a result your complainant sustained severe injury and has to undergo treatment of private doctor and the accused persons still coming to the father's house of the complainant and threatening the complainant several times saying that they will misappropriate the articles given at the time of their marriage.

- 11. That your complainant went to Katsila P.S. to inform the matter but the police did not take any complain from the complainant and directed your complainant to take shelter in the Court of Law.
- 12. That the details of the occurrence will be given at the time of trial.
- 13. That the accused persons committed offence U/s 498(A)/ 323/406/34 of I.P.C. 3 & 4 of D.P. Act.

It is therefore prayed that your Honour may graciously be pleased to send this petition of your complainant to the O.C. of the Katsila Police Station with a direction to treat the complain as F.I.R. U/s 156(3) of Cr. P.C. for the ends of justice.

And for this act of kindness your complainant shall be duty bound and ever pray.
