
The above-named complainant beg to state as follows:

- 1. That the present petitioner Fatik Kuiry is resident of village + Post- Begunkudor, P.S- Kotshila, Dist-Purulia, W.B, witness no 2 and witness no 3 are elder brothers of the present petitioner.
- 2. That on 21/06/2020, at about 3.00 to 3.30 PM (Afternoon) the present petitioner and his elder brother namely Rabi Kuiry (witness no2.) got information over mobile phone from their elder brother namely Chandi Charan Kuiry (witness no 3)that he has been surrounded and confined in his house at Tola-Bhelatarh, Begunkudor, P.S- Kotshila, Dist- Purulia by the accused persons armed with deadly weapons in order to murder him. And Chandi Charan Kuiry also told the present petitioner to come quickly and to rescue him from the hands of the accuseds.
- 3. That soon getting the information from Chandi Charan Kuiry, the present petitioner along with Rabi Kuiry went to rescue Chandi Charan Kuiry from the place of confinement at Tota- Bhelatarh, Begunkudor, P.S- Kotshila, Dist- Purulia, W.B.
- 4. That when the petitioner reached at Tola- Bhelatarh, Begunkudor, on the way in between the road from Jaharatu to Duyasini under P.S- Kotshila, Dist- Purulia, W.B, the petitioner and his brother Rabi Kuiry was stopped by Khagen Mahato S/O Mahendra Mahato (Accused no 1) and other accused persons mentioned above,



all of them armed with Sabol, Kural, Lathi, Kathari and the accused persons surrounded and assaulted the petitioner and his elder brother Rabi from all sides.

- That before understanding anything, Haraprashad Mahato (Accused no 2) assaulted the petitioner over his forehead by 'Kural' as a result the petitioner sustained bleeding injury and he fell on the ground after receiving such deadly blow from Haraprashad Mahato. When the petitioner was knocked down on the ground, Sanatan Mahato @ Bhukhal Mahato (Accused no 3) assaulted the petitioner by 'Kuthar' over his head. Ramprashad Mahato (Accused No.4) and Rosu Mahato (Accused No-5) assaulted Rabi Kuiry the elder brother of the petitioner by 'Sabal' over his head and he also sustained grave injury. Ruri Mahato (Accused no 9.) and German Mahato (Accused no 6.) caught hold the petitioner and his brother and started pulling them when Rishikesh Mahato (Accused no 7.) assaulted both petitioner and his brother Rabi by 'Lathi' over various parts of their body. Ashu Mahato (Accused no 8) and Basna Mahato (Accused No 10.) gave a fear blow of 'Lathi' over the left hand of the petitioner. The petitioner and his elder brother Rabi started shouting 'Bachao bachao, amader meray phelbay'.
- 6. That hearing the hue and cry the local people and Chandi Charan Kuiry any how managed to arrive at the place of occurrence seeing Chandi Charan Kuiry, Ruri Mahato(Accused no 9) also assaulted him by 'Lathi' and gave threat calls that next time it will be your last day. Then the accused persons fled away.
- 7. Then the petitioner called his family members over phone and his family members arrived and taken the petitioner and his two-elder brother to Kotshila BPHC, where they were given elementary treatment but as their condition was not good for better treatment, they were referred to Purulia Deben Mahato Sadar Hospital. Rabi Kuiry was admitted for 3 days at Purulia Deben Mahato Sadar Hospital and the petitioner was admitted for 5 days.



- 8. That the incident was duly informed to the Kotshila P.S by the complainant and witnesses but Police personal did not take any step against the miscreants, finding no other alternatives your petitioner has knocked the door of Superintendent of Police, Purulia on 08/09/2020 but nothing has been done from his end.
- 9. That your petitioner is a law-abiding citizen having full faith in the justice delivery system of the country and for all these it is desirable and prayed that this case should be converted to a police case.

It is respectfully prayed that under such Circumstances and for the reasons stated above and for the ends of Justice, Your Honour may be graciously pleased to direct the O/C Kotshila P.S to investigate the case by treating the complaint as F.I.R as provided U/S-156(3) Cr.P.C. and in accordance with the law.
