Sir,

In producing here with 06(Six) arrested accused persons namely (1) Sambhunath Rajawar (23) S/O Sasibhushan Rajawar of village- Gopalpur, PS- Manbazar, Dist- Purulia (2) Mahesh BAuri (18) S/O Pintu Bauri of village- Manbazar Muchaikuli, PS- Manbazar, Dist- Purulia (3) Ajay Bauri (23) S/O Sunil Bauri of village- Manbazar Muchaikuli, PS- Manbazar, Dist- Purulia (4) Madhusudhan Mahato (30) S/O Debulal Mahato of village- Boro Kumar para, PS- Boro, Dist- Purulia (5) Shampada Mahato (19) S/O Ganesh Mahato of village- Hutupathar, Po- Kamalpur, PS- Patamda, Dist – East Singhbhum (Jharkhand) (6) Uttam Bauri (19) S/O Jaydev Bauri of village- Porasigora Madhabpur, PS- Manbazar, Dist- Purulia

I beg to state that today (16.10.2020), I was directed to find out whether the people wearing mask or not at Manbazar Market area. This refers to Manbazar PS GDE No- 652, Dtd. 16.10.2020. Accordingly, I had been to Manbazar Market area at about- .18:35 hrs I found that the above noted persons, were roaming aimlessly at Bazar area. Myself along with force detained them at Manbazar Indkuri more On Purulia –Manbazar road under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for not wearing mask at public place . Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life.

I arrested them for Disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention.

All the process was done in between 19:15 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present as witness. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar through duty officer ASI. Subhendu Mahato for taking necessary action as per law. I handed over all the relevant papers, Memo of arrest, Inspection Memo, Bail Bond & P/R Bond.
