Sub: Complain to start a specific case.

Sir,

In producing herewith one seized Truck bearing No -WB 37D/9692 loaded with steam (raw) coal approx 15 M.T. do hereby lodge a complaint against the driver of vehicle No- WB 37D/9692 , owner of vehicle No- WB 37D/9692 and owner of seized coal from the vehicle No- WB 37D/9692 to the effect that on (25/10/2020), I, SI Bablu Ghosh along with (1) C/1353 Atanu Ganguly (2) NVF/660 Ranjit Kumbhakar all of Neturia PS were engaged in anticrime night mobile duty in PS area vide Neturia PS GDE No- 1204 Dt. 25.10.2020. In course of night Mobile Duty, at about 02:15 hrs (26.10.2020) when we reached near Gobag, I received a credible source information that one Truck bearing No- WB 37D/9692 loaded with illegal coal coming from Asansol side and will transport the same to Raghunathpur side through Barakar - Purulia road in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately rushed towards Mekatola and started Naka checking there immensely to intercept the above noted vehicle. After some time found one truck is coming from Barakar side, suddenly the vehicle stopped about 50/60 meter away from us and one person seems to be the driver of the vehicle got down from the vehicle and started running towards dark side beside the road. We chased to apprehend the person but in spite of hot chase he managed to flee away. Then we searched the vehicle and found that the vehicle (Truck) bearing no - WB 37D/9692 has been loaded with steam (raw) coal approx 15 M.T.

So, there is reason to believe that the driver, owner of coal and registered owner of the said vehicle have collected the said coal either by theft or by any fraudulent means and tried to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.


Accordingly I seized the said truck bearing no - WB 37D/9692 loaded with steam (raw) coal of approx 15 M.T. under proper seizure list duly signed by the Police witnesses, since no public witness was found as well as collected approx 05 kg steam (raw) coal from the above noted seized truck as sample and sealed & labeled the same. I also arranged to keep the vehicle loaded with at PS compound.

Under the above fact & circumstances a specific case may kindly be started against the (1) driver of truck bearing registration No - WB 37D/9692 (2) Registered owner of truck bearing registration No - WB 37D/9692 and (3) (2) owner of the coal, seized from truck bearing registration No - WB 37D/9692 under proper section of law.


