Sub:- Complaint to start a specific case.

Sir,

In producing herewith the arrested accd Arjun Bauri (20 yrs) s/o Sanjit Bauri of Ituri PS Saltora Dist Bankura along with seized Tractor bearing No- WB 81/2550 (Tractor) loaded with stone approx 100 cft. under proper seizure list. I beg to submit that I, ASI Tarapada Meta along with C/ 1224 Gajan Murmu C/480 Uttam Bauri and 1260 Santosh Saren , all of Neturia PS were performing evening mobile duty today on 4.10.2020 vide Neturia PS GDE No. 180 and CC No. 2714/20 and at about 20.25 hrs received a credible source information that one Tractor was coming from Gobag side towards Sarbari side loaded with stone illegally. Accordingly I intimated the matter to you over mobile phone and as per your direction we left to work out the information and while we reached at Bartoria (Purulia – Barakar Road) at about 20.45 hrs we found that the above noted Tractor was coming from Gobag side . I intercepted the Tractor and found the registration number given by my source is matched. On search found that the Tractor is loaded with approx 100 cft stone. I asked the driver to produce any valid documents in respect of stone loaded in the Tractor as well as the valid documents in respect of that Tractor but he failed to produce any valid document in respect of stone and Tractor. As such there is every reason to believe that the driver and owner of the Tractor with ill motive were transporting the stone illegally as per their regular practice without any valid document in support of carrying stone. So, they committed offence punishable U/S- 379/411/413/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957. Hence I arrested the driver Arjun Bauri (20 yrs) s/o Sanjit Bauri of Ituri PS Saltore Dist Bankura after observing all formalities regarding arrest and seized the Tractor bearing No- WB 81/2550 loaded with stone approx 100 cft under proper seizure list in presence of police witnesses duly signed by them and I brought the said Tractor to Neturia P.S.

Therefore, I pray before you that a case against the driver namely Arjun Bauri (20 yrs) s/o Sanjit Bauri of Ituri PS Saltore Dist Bankura and owner of Tractor bearing No- WB 81/2550 may kindly be started and arrange for its investigation.
