In producing herewith one arrested accd. person namely Sk.Hussain(22yrs) S/o Lt. Sk. Fatik of Village- Anara Bajikartar, PS- Para, Dist. Purulia with seized article i.e 16 (Sixteen) pcs sealed bottles of Country Spirit styled as "DIL Se" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list, I beg to submit that today (23.10.2020) during my Evening Mobile duty I received credible source information that one Sk. Hussain (22yrs) S/o Lt. Sk. Fatik of Village- Anara Bajikartar, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor for selling during Durga Puja. Accordingly I informed it to O/C Para PS andas per his instruction in between 18.45 hrs to 19.15 hrs I held raid in the house of Sk.Hussain(22yrs) S/o Lt. Sk. Fatik of Village- Anara Bajikartar, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as 'Dil Se'. On seeing Police the people who were buying liquor fled away.I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license. So I seized 16(sixteen) bottles of 'Dil Se' country spirit containing 600 ml each which were kept in there under proper seizure list in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guidelines provided by NHRC/WBHRC and informed his family members.

The above noted arrested accd. namely Sk.Hussain(22yrs) S/o Lt. Sk. Fatik of Village- Anara Bajikartar, PS- Para, Dist. Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Sk.Hussain(22yrs) S/o Lt. Sk. Fatik of Village- Anara Bajikartar, PS- Para, Dist. Purulia and arrange for its investigation.
