In producing herewith 03 (Three) arrested accused persons namely 1) Fajibul Sah (26yrs) S/o Israil Sah village- Bamunbaid, 2) Paban Bauri (19yrs) S/o Shyamapada Bauri village Itagora Para, 3) Krishnapada Mahato village- S/o Lt- Pashupati Mahato village Kinisayer, all of PS- Para, Dist- Purulia.

I beg to state that today (14.10.2020), I was directed to find out whether wearing of mask by the public has been properly maintained at Para Bazar area or not. Accordingly, I had been to Para Bazar near Hospital More at about 18.15 hrs found that a gathering appeared at Para Bazar near Hospital More, none of them were wearing musk. On seeing Police party they have tried to escape from the grip of police party but some failed to escape due to efficient effort of police party. On being asked they disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated Govt. order. In view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order Noviolated Govt. order. I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e.as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. All the process was done in between 18.25 hrs to 18.35 hrs. There was every chance of breach of peace and requiring of offence if not arrested.
