Respected Sir,

In producing herewith one arrested accd. person namely Sanjit Swarnakar (35 Yrs) S/o Lt. Amrit Swarnakar of Vill- Dubra, PS- Para, Dist. Purulia with seized article i.e 15 (Fifteen) pcs sealed bottles of Country Spirit styled as "DIL SE" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list.

I beg to submit that today (18.10.2020) during my Evening Mobile duty in between 18.05 hrs to 18.35 hrs acting on a tip off a raid was conducted in the house of Sanjit Swarnakar (35 Yrs) S/o Lt. Amrit Swarnakar of Vill- Dubra, PS- Para, Dist. Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of said liquors. As such I seized 15 (Fifteen) pcs sealed bottles of Country Spirit styled as "DIL SE" each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accd. person. During arrest maintain all rules and norms as well as guideline of NHRC/WBHRM and also informed his family member.

The above noted arrested accd. Sanjit Swarnakar (35 Yrs) S/o Lt. Amrit Swarnakar of Vill- Dubra, PS- Para, Dist. Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Sanjit Swarnakar (35 Yrs) S/o Lt. Amrit Swarnakar of Vill- Dubra, PS- Para, Dist. Purulia and arrange for its investigation.
