Sir,

In producing here with 02(two) arrested accused people namely (1) Sunil Sing Sardar (26 yrs), S/O- Lt. Naresh Sing Sardar (2) Tapas Sing Sardar (25 yrs), S/O- Lt. Ajit Sing Sardar both of vill- vill-Raisa, PS-Hura, Dist- Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (12/10/2020) I was engaged in evening mobile duty at Hura- Puncha road near Napara football ground with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 417 Dtd- 12/11/2020 and CC No-3630 Date-12/10/2020 Accordingly, I was performing duty at Hura- Puncha road near Napara football ground the above noted people were roaming aimlessly without wearing mask. I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of compulsory wearing of mask during this pandemic situation. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 16.45 hrs to 17.00 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Sunil Sing Sardar (26 yrs), S/O- Lt. Naresh Sing Sardar (2) Tapas Sing Sardar (25 yrs), S/O- Lt. Ajit Sing Sardar both of vill- vill-Raisa, PS-Hura, Dist- Purulia, as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51 of National Disaster Management Act, 2005 and arrange for its investigation.
