Sir,

In producing here with 03(Three) arrested accused people namely (1) Santosh Mahato(29 yrs), S/O- Sristidhar Mahato of vill-Rajagram (Jharbagda), PS-Manbazar, Dist- Purulia (2) Samrat Bauri (25 yrs), S/O- Saktipada Bauri of do (3) Indrajit Mahato (26 yrs), S/O- Sunil Mahato of vill- Dighi, PS- Boro, Dist- Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (10/10/2020) I was engaged in spl mobile duty at Budpur area with forces to find out whether the lock down has been implanted properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 343 Dtd- 10/10/2020 and CC No-3615 Date-10/10/2020 Accordingly, I was performing duty at near Budpur Bridge area at about 14.445 hrs, the above noted people were roaming aimlessly without wearing mask. I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of compulsory wearing of mask during this pandemic situation. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 14.45 hrs to 15.25 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Santosh Mahato(29 yrs), S/O- Sristidhar Mahato of vill-Rajagram (Jharbagda), PS-Manbazar, Dist- Purulia (2) Samrat Bauri (25 yrs), S/O- Saktipada Bauri of do (3) Indrajit Mahato (26 yrs), S/O- Sunil Mahato of vill- Dighi, PS- Boro, Dist- Purulia, as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51 of National Disaster Management Act, 2005 and arrange for its investigation.
