Sir,

In producing herewith one arrested accd. person namely Sanjoy Gorain (29 yrs) S/O Bhadari Gorain of Vill- Chargali, PS- Purulia (M), District - Purulia with seizure list and seized articles.

I beg to submit that today (28.10.2020) I was detailed to perform mobile duty in PS area along with force i) C/857 Chepual Murmu, ii) 809 Madhusudan Mahato & iii) HG/1618 Haripada Gorain vide Purulia (M) PS C.C. No 2860/2020 Dt. 28.10.2020 and GDE No 1154 Dtd. 28.10.2020. During my mobile duty, I received a secret tip off an illegal possession of huge amount of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the village Chargali under this PS and arrived at the spot and as per indication conducted raid in the House of Sanjoy Gorain s/o Bhadari Gorain at 18.15 hrs. During the raid 2/3 persons fled away from his house and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Country spirit and foreign liquor for selling illegally in his house so that he could gain more amount from the selling of foreign liquors styled as Officers choice/3x Rum, and Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said of foreign liquors/ Country Spirit at his house. Subsequently, I seized i) **180 bottles of country sprite styles as Dilkhush containing 600 mls each (amounted Rs-10,800/-)** ii) **10 bottles of foreign liquors styles as M/C Dowell No-I RUM containing 375 mls each (amounted Rs-2900/-)** iii) **06 bottles foreign liquors styles as Officers choice containing 375 mls each (amounted Rs- 2900/-)** iv) **07 bottles foreign liquors styles as Officers choice containing 180 mls each (amounted Rs-1050/-)**. From which 01 bottle of country sprite styles as Dilkhush containing 600 mls, 01 bottles of foreign liquors styles as M/C Dowell No-I RUM containing 375 mls, 01 bottles of foreign liquors styles as Officers Choice containing 375 mls, 01 bottles foreign liquors styles as Officers choice containing 180 mls were taken from those 203 bottles as samples under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Sanjoy Gorain (29 yrs) s/o Bhadari Gorain of Vill- Chargali, PS- Purulia (M), District - Purulia committed offence u/s 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of foreign liquor/ Country Spirit in his house.

Under the fact and circumstance kindly take necessary lawful action against Sanjoy Gorain (29 yrs) s/o Bhadari Gorain of Vill- Chargali, PS- Purulia (M), Dist - Purulia.
