

1. That the complainantis the resident of vill/PO:_Nildih, PS:_Raghunathour, Dist:Purulia(W.B) within the jurisdiction of this Ld.court.

2. That wife of Bholanath Mondal is familier to complainant and his family and as she was complainant's "BOUDI" (Sister-in-law) by village courtsy as younger brother of complainant used to talk with her for which Bholanath Mondal did not like him and used to threat him.

- 3. That on 16-08-2020 at about 5-30 A.M. complainant's younger brother Srikanta Mondal accompained with elder handicapped broth er for nature's call and at a distance of 150 feet from their house in the way to pond in between village more near a saloon Bholanath Mondal attacked them with sharp sickle(Kaste) for attempt to murder.
- 4. That after being attacked by Bholanath Mondal both of them (Srikanta Mondal and elder brother) shouted for help, then the complainant rushed to the spot and tried to save them and then Bholanath became furious and tried to attack with that weapon at random against the complainant which he pick with his left hand to save his head and throat. As Bholanath attempt to cut his throat and betried to pick that sharp weapon with his left hand as a result his left thumb cut deeply and bleed profusely. In the meantime many people of that village assembled there seeing them said Bholanath Mondal fled away.
- 5. That this is pertinent to mention that before causing the thumb injury of complainant that Bholanath Mondal physically assaulted complainant's younger brother and elder brother and abused them with filthy languages and when he left that place before leave he also assaulted their mother who was nearly the spot and he also threatened all of them with dire consequences.

6. That after met incident complainant's mother Dipali Mondal and his uncle Dilip Mondal accompained him to S.D. Hospital at Raghunethpur for treatment while they were in the way to Hospital that Bholanath Mondal continued his threat and abusive languages upon them and also threatened to take all of their lives.

- 7. That the complainant and his mother Dipali Mondal got treatmen -t from S.D. Hospital Raghunathour and after treatment they released from that Hospital.
- 8. That for treatment and for illness complainant could not lodge complaint before Raghunathpur P.S. on 16-08-2020 and as the complainant and every member of his house are fritened after that incident, complainant lodge a complaint before Raghunathour P.S. on 17-08-2020, but the concerned P.S. did not receive that, as such on 22-08-2020 the complainant send that complaint by Regd. Post which delivered to Raghunathour P.S. on 24-08-2020 but they did not take any action against Bholanath Mondal.
- 9. That on 10-09-2020 the complainant send a prayer before the S.P. Purulia for lodging the F.I.R. against that Bholanath Mondal S O Dasarath Mondal of vill/PO:- Nildih, but till now no action taken against said Bholanath Mondal which is very unfortunate.
- 10. That the accd. person thus committed offence U/S 341/323/324/ 325/326/307/506 I.P.C.
- 11. That finding no other alternative the complainant have to take shelter before the Ld.court for the redressal of his grievance.
