In producing herewith arrested 03 (Three) accused persons namely (1) Md. Belal Ansary (32), S/O Mohiruddin Ansary of Kukurtanga, (2) Rijuan Ansary (25), S/O Rashid Ansary of Velatard and (3) Jaydev Bauri (23), S/O Subodh Bauri of Ichhar, All are PS - Santaldih, Dist. - Purulia, along with original seizure list and seized articles i.e (1) One Iron Rod cum crowbar total length approx 03 feet from the possession of Md. Belal Ansary, (2) One Iron made Cuttery total length approx 01 feet 2.5 Inch with handle from the possession of Rijuan Ansary and (3) One Nylon rope and one Torch light from the possession of Jaydev Bauri.

I beg to report that on 11/10/2020 at 19:45 hrs received an information from secret source that some miscreants had assembled in a dark place at football ground near Parashya Ashram under Santaldih PS with deadly weapons with a intend to commit dacoity any house/shop/petrol pump under Santaldih PS jurisdiction and they were preparing themselves for the said purpose. Accordingly, the matter was diarized in Santaldih IC BCW GDE No. 119, dated - 11/10/2020 and the matter was informed to IC, Santaldih PS. As per order of IC, Santaldih PS, I, SI Dipankar Biswas along with C/105 Partha Tewary, JC/830 Shyam Kanta Maity, all of Santaldih I.C (BCW) under this PS, left the Investigation Centre to work out the information of secret source as noted above vide Santaldih I.C. (BCW) CC No. 1240, dated - 11/10/2020 and Santaldih I.C. (BCW) GDE no. 120, dated - 11/10/2020 by Govt. vehicle. The evening mobile officer SI Partha Pratim Chakraborty and his force were communicated over cell phone to accompany with us for the above purpose. At about 20:25 hrs we arrived at football ground near Parashya Ashram and parked the Govt. vehicle in a hide them in secret place and I briefed other officer and force properly, guarded and cordon the area and approached towards the back side of the football ground. After sometimes we watched that some persons were whispering among themselves. On seeing Police Party they started to flee away. After a hot chase we apprehended above noted 3 (three) accused persons when 7/8 others managed to escape away. On being asked the above noted accused persons disclosed their identity as stated above. On interrogation they did not give any satisfactory answer about their present there. They also made different statement about their presence at football ground near Parashya Ashram in different times. On search (1) One Iron Rod cum crowbar total length approx 03 feet from the possession of Md. Belal Ansary, (2) One Iron made Cuttery total length approx 01 feet 2.5 Inch with handle from the possession of Rijuan Ansary and (3) One Nylon rope and one Torch light from the possession of Jaydev Bauri. They did not give any satisfactory reply about the above articles which were in their respective exclusive possession.

After prolonged interrogation they confessed that, they had assembled there to prepare and commit Dacoity at the petrol pump of Dines Mahato at Paharigora under Santaldih PS. Accordingly, I Seized those above noted articles after preparing proper seizure list duly signed by the witnesses as well as 03 (three) alleged persons at 20:45 hrs to 21:15 hrs. The above noted accused persons have been arrested on 11/10/2020 at 21:20 hrs to 21:35 hrs after maintaining all formalities and informing them the ground of arrest U/s 50 Cr PC. Before their search we requested them to search the Police team and they also searched us and found nothing except uniform and other govt. properties

Hence, I, pray before you that a specific case U/S - 399/402 IPC may kindly be started against the 03 (three) accused persons (1) Md. Belal Ansary (32), S/O Mohiruddin Ansary of Kukurtanga, (2) Rijuan Ansary (25), S/O Rashid Ansary of Velatard and (3) Jaydev Bauri (23), S/O Subodh Bauri of Ichhar, All are PS - Santaldih, Dist. - Purulia and 7/8 others and arrange for its investigation.
