Sir,

I, SI Uttam Chatterjee, S/O- Lt. Dukhabhanjan Chatterjee of Pathakpara, P.S+ Dist-Bankura now posted at Santuri PS, Dist-Purulia do hereby produce (1) Madhu Kora (45 yrs) S/O- Lt. Sanjilal Kora of Marbedia, P.S- Santuri, Dist.- Purulia, (2) Kanu Hembram (40 yrs) S/O- Lt. Nayan Hembram of Vill-Manjuri, P.S- Santuri, Dist.- Purulia, (3) Buddheswar Hansda (42 yrs) S/O-Sitaram Hansda of Marbedia, PS-Santuri, Dist-Purulia do hereby lodge a written complaint against them, to the effect that today on 19.10.2020 while I along with C/233 Upananda Das & C/1485 Swarup Nandi of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 754 dtd. 19.10.2020 vide C.C. No. 3803/20 dtd. 19.10.2020 for implementation of Government rules of Disaster Management Plan and while we returning from Marbedia border side under Santuri P.S jurisdiction and reached at Marbedia Morh through Raghunathpur - Saltora (SH-8) road at about 17:45 hrs. found that the above noted 03(three) persons were gossiping without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Madhu Kora (45 yrs) S/O- Lt. Sanjilal Kora of Marbedia, P.S- Santuri, Dist.- Purulia, (2) Kanu Hembram (40 yrs) S/O- Lt. Nayan Hembram of Vill-Manjuri, P.S- Santuri, Dist.- Purulia, (3) Buddheswar Hansda (42 yrs) S/O-Sitaram Hansda of Marbedia, PS-Santuri, Dist-Purulia, under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
