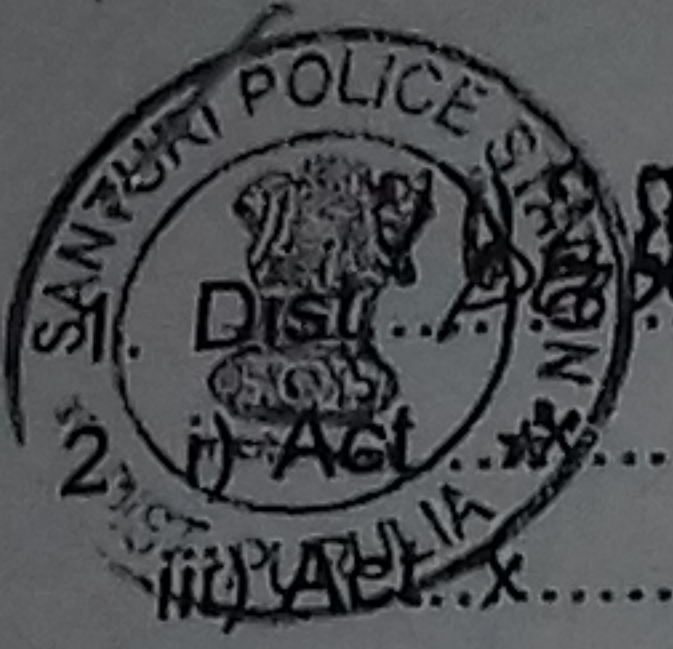

Respected Sir,

In producing here with the arrested accused persons namely (1) Dhananjoy Karmakar (38 Yrs), S/O- Narayan Chandra Karmakar of Vill- Sarangapur, P.S - Gangajolghati, Dist – Bankura (2) Sanjoy Goswami (35Yrs), S/O- Lt. Gangadhar Goswami of Vill-Khiraiboni, PS- Joypur, Dist- Bankura (3) Anil Kumar Singh (40Yrs), S/O- Upendra Prasad Singh of Vill- Narepur bank bazaar Bachhwara, PS- Bachhwara, Dist- Begusarai (Bihar) along with 09 liters 600 ml Country Spirit (16 bottle X 600ml) value of Rs- 60 X 16= 960/- seized under proper seizure list, I beg to submit that today (on 11.10.2020) I along with force while performing special mobile duty at about 21:05 hrs received a credible source information that 03 (three) persons are stocking and selling Country Spirit without any valid license beside the road towards Kankurkiyari near Benagoria village under Santuri PS, Dist- Purulia. Accordingly, I along with force proceeding towards the spot to work out the source information and found the above noted persons were selling country spirit bottles among customers. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said persons are stocking Country Spirit bottles for selling. On demand, they failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrested them after preparing proper arrest memo as they committed offence U/S 46A(C) B.E. Act 1909 and supply copy to them. Then, I seized and labeled 16 (Sixteen) bottle 'DIL SE' country spirit containing 600ml (each bottle) and amounting Rs-60/- (Sixty) each bottle, Total amounting Rs- 960/- under proper seizure list duly signed by the witnesses out of which one bottle is seized and labeled as sample.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A (C) B.E. Act 1909 against the arrested accused persons namely (1) Dhananjoy Karmakar (38 Yrs), S/O- Narayan Chandra Karmakar of Vill- Sarangapur, P.S - Gangajolghati, Dist – Bankura (2) Sanjoy Goswami (35Yrs), S/O- Lt. Gangadhar Goswami of Vill-Khiraiboni, PS- Joypur, Dist- Bankura (3) Anil Kumar Singh (40Yrs), S/O- Upendra Prasad Singh of Vill- Narepur Bank Bazar Bachhwara, PS- Bachhwara, Dist- Begusarai (Bihar) and arrange for its investigation.
