M. Patra & NVF-940 Bhairab Mahato of Tamna PS as per direction engaged in evening mobile duty within Tamna PS area, (Reference Tamna P.S G.D.E No. 344 dtd. 10.10.2020 vide C.C. No. 628/20 dtd. 10.10.2020 for implementation of Government rules of Disaster Management Plan reached at Chengi Morh at about 19:35 hrs. and found that the above noted 08(Eight) persons were gossiping without wearing mask and not maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining social distancing which violates the compliance of norms of Govt.of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life . So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.
