Dear Sir,

With due respect I would like to bring in to your notice the horrible assault that I had faced along with other family members. On the morning of the 19/11/2020 (around 9.15am) i was engaged in talking to my wife namely: Smt. Lal Jharo Devi at my premises situated at Arvind Palli, Lower Beniasol, Post- Adra, P.S- Adra, District- Purulia (WB). My unmarried daughter Dr. Arti Chowdhary and my grand- daughter Miss Puja Kumari (D/o- Jitendra Kumar Yadav) were also present. Suddenly my deceased son's (late Rama Shankar Chowdhary) wife Pratima Chowdhary along with her son Bijay Kumar Chowdhary, who are also reside separately in another quarter room of my house, started to shout loudly in abusive language and they came in front of us, armed with lathi and bricks and demanded to have the roof of the single storied building for the construction of few rooms for their use. I denied this demand and due to this disagreement Pratima Chowdhary and Bijay Kumar Chowdhary became more furious and started hitting all of us with lathi and bricks. Pratima Chowdhary assaulted my grand daughter Puja Kumari with bricks which has resulted in a grievous head injury as she started bleeding profusely. Whilst myself, my wife and Arti Chowdhary tried to rescue Puja Kumari, Bijay Kumar Chowdhary assaulted me with lathi over my left hand and also hit Arti Chowdhary's right hand. Pratima Chowdhary and Bijay Kumar Chowdhary continuously attacked on us with lathi and bricks. Our neighbours came to our rescue and protected us. Pratima Chowdhary and Bijay Kumar Chowdhary giving threatening to kill us because I am not agreeing to give them the roof of my house for construction. Their bitterness towards us has gone to such a level that they are still threatening me by saying that if I lodge police complain, she will charge a false rape case on me. Bijay Kumar Chowdhary threatening us if I lodge police complain he will shoot us. Pratima Chowdhary has been demanded for quite a bit of time that we leave the house and transfer the property in her name. In that way she would be able to enjoy the whole house with her son and her side of the family.

This incident has been witnessed by people from our locality. I am 75 years old man suffering from severe spondylitis my wife is equally old and not

in her best health. Not only are we having to bear the unfortunate tragedy of our only son Rama Shankar Chowdhary's death in the year 2011, which had impaired us mentally already, but also physically instability due to old age. On top of this such behaviours by Pratima Chowdhary and Bijay Kumar Chowdhary are making us more mentally and physically impaired. We were under treatment in Shalka Hospital Raghunathpur and therefore, I was unable to be report this incident any earlier. The medical papers are attached with this application.

Therefore, I am earnestly requesting you to arrange for a proper investigation in this regard immediately and take proper legal action against said Pratima Chowdhary and said Bijay Kumar Chowdhary. The particulars of whose are given below specifically.
