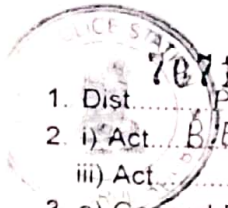

Sir,

In producing here with one arrested accused namely Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill- Gayadih, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 12 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-60 of each bottle.

I SI Subrata Sadhu of Adra PS do here by lodged a complaint against accused namely Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill- Gayadih, PS-Adra, Dist- Purulia to the effect that on 31/10/20 at about 06:05 hrs I received a telephonic information from a reliable source that one Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill- Gayadih, PS-Adra, Dist- Purulia has been stock of country spirit illegally at his Tea Shop at Gayadih Village. After getting such information I informed to my O/C and as per his direction I along with my accompanied force left the PS vide Adra PS GDE NO-1188 dtd.31/10/20 reached at Gayadih village at about 06:35 hrs and hold raid in the Tea Shop of said Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill- Gayadih, PS-Adra, Dist- Purulia and found that the said person selling liquor at his Tea shop and after seeing the Police party some person fled away and said Binod Ram Khatik has try to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill- Gayadih, PS-Adra, Dist- Purulia selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Binod Ram Khatik (50 Yrs) S/O Lt. Bodhi Ram Khatik of Vill- Gayadih, PS-Adra, Dist- Purulia under proper section of law.
