Sir,

I, P.S.I Biswajit Chatterjee of Balarampur P.S do hereby lodge a complaint as suomoto against 1) Subhadip Pal (22 yrs) S/O- Dilip Pal of Balarampur Hattola near Lalimoti Girl's High School, P.S- Balarampur, Dist.- Purulia, 2) Nayan @ Raja Mahanty (26 yrs) S/O- Narayan Chandra Mahanty of Balarampur Bus stand, P.S- Balarampur, Dist.- Purulia.


I like to note here that today i.e on 09.11.2020 I, P.S.I Biswajit Chatterjee along with C/649 Digam Ch. Mahato, C/841 Chanchal Paramanik, C/2989 Prasenjit Das, C/2752 Santanu Ghosh in full uniform were engaged in special anti crime Naka duty in c/w Pre Kali Puja Drive at Berma Check Post vide Balarampur P.S GDE No-415 date-09.11.2020 & C.C. No- 4598/20 date- 09.11.2020 & at about 21:55 hrs. we saw a white colour Four Wheeler Car coming from Malti side, accordingly, we signaled the car to stop at checking point behind other vehicles which were also being checked but all of a sudden, the said vehicle approached towards us with a huge speed & collided with the guard rail which were place to spot the vehicles & the vehicle fled away towards the Balarampur town leaving sufficient reason to believe that either they have committed any crime or they are not having any valid documents. As such, we chased the vehicle & intercepted the vehicle near St. Xavier's School on NH-32. The vehicle was being driven so rashly & negligently that it could have hit our Police team.

After intercepting the vehicle, I found that driver along with one other in the vehicle who on being intercepted started abusing us & used derogatory words to Police persons. We tried to make him calm down & asked him to produce documents of the vehicle but they became more furious & suddenly attacked on one of the Constable namely Prasenjit Das (C-2989) who was acting in the discharge of his duty causing injury on his person. While we tried to stop him, Both of them tried to prevent us from discharging Govt. duty & threatened us to " DEKHE NEBO AMRA LOCAL CHELE, AMADER GARIR KONO PAPER LAGE NA, AMRA SOB LAW ER UPORE." Finding no other alternative we detained them & found their name as 1)Nayan @ Raja Mahanty (26 yrs) driver of the vehicle S/O- Narayan Chandra Mahanty of Balarampur Bus stand, P.S- Balarampur, Dist.- Purulia, 2) Subhadip Pal (22 yrs) S/O- Dilip Pal of Balarampur Hattola near Lalimoti Girl's High School, P.S- Balarampur, Dist.- Purulia & the vehicle was a white colour SWIFT DEZIRE having Reg. No- JH05CT/7773. On being asked Nayan @ Raja Mahanty

could not produce any valid driving license. As such, I seized the vehicle having Reg. No- JH05CT/7773 after preparing seizure list duly signed by the Police witnesses as there were no public witnesses at that area, after that, I also arrested them maintaining all guide line regarding arrest.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started against the above noted persons.
