

Sir,

I, the undersigned would like to draw your kind attention and inform you below mentioned facts:-

1) That, I am a Group-D employee working near Kuman River Rly bridge, near Bedada Shir Mandir under SSE/P-Cray/CII (Chandil), Engg deptt, Adra division, SER which is under your jurisdiction.

2) That I am working at the mentioned place from the date 27.10.2020 and from this very date the accused persons namely Mansaram Majhi &/o - Not Known working as SSE under SSE/P-Cray/CII/Adra/SER, PO - Tom Kocha, PI - Narendhir, St - Sevaikela - Kharlamra (Jharkhand), Pin - 832401 and Sana Ansary &/o - B. Ansary working as Track Maintainer under same mentioned office are repeatedly misbehaving, torturing ~~and~~ assaulting and harassing me intentionally as there is a suit which I have filed before CAT/Kolkata Bench against the prejudice & behaviour of the Rly officials.

3) That, as on 27.10.2020 at about 04:30 P.M. while I was returning back to my home then on my way near Bedada Shir Mandir both the accused persons stopped me and assaulted me by using criminal force and also threatened me if I would not act according to their wish then they will spoil my service life as they ~~are~~ ^{have} very superior rank than me and with their strong economic strength they can purchase both police officials and judge in the court.

at about 09:30 A.M.

4) That, again as on 31.10.2020 when I went to do my duty there with the old gonge and envy at first they marked Absent in Attendance Sheet for the day and by calling me in a room nearby where no one was there except Mansaram Mithi and other Lalm Ansary they used filthy and abusive languages for me and my family. They threatened me to damage ~~and~~ my family as they betterly know my wife is a Chronic Kidney disease-Stage-3 patient and my lonely daughter only two years old is a Thalassaemia minor patient and they are alone at Bumpur Rly. Offr and they threatened to ruin them with criminal force. They bitted me too with deadly weapon and somehow I managed to escape from there.

5) That, after I came out from there I went to Balasampur Hors. Hospital for the treatment of my hots and injuries.

So, at the consequences of the above mentioned acts I am feeling unprotected to perform my duty and also worried about my family. I therefore, request you to lodge an FIR against the above mentioned accused persons so that they could get a punishment before the law and I could get justice.
