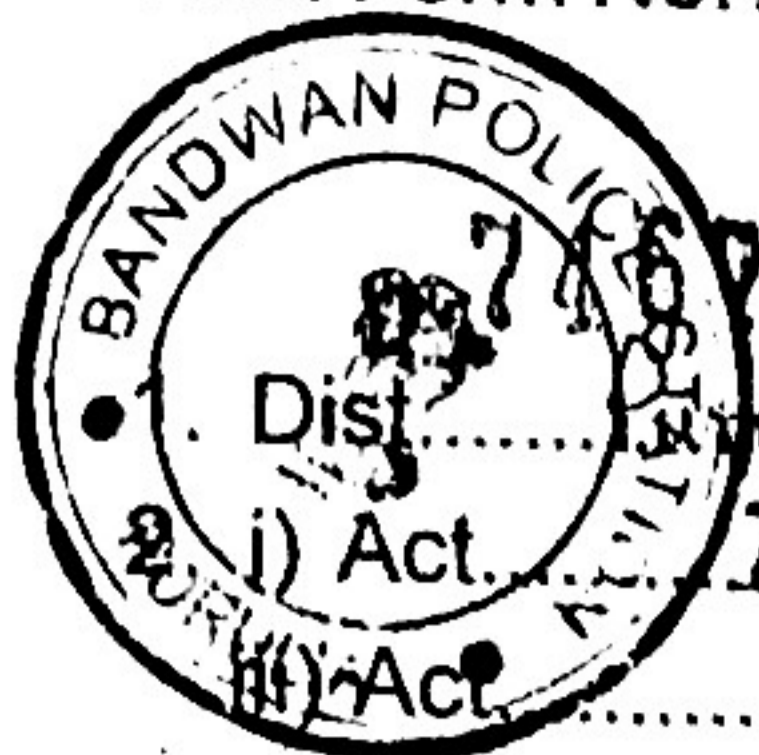

I, PSI Anupam Gorain of Bandwan PS, beg to report that as per your kind order vide Bandwan PS GDE No-88 Date-03.11.20 & CC No-3050/20 Date-03.11.2020 on today i.e on 03.11.2020 at about 11:05 hrs while myself along with force were performing day mobile duty at Bandwan Bus Stand and found the above noted persons are coming from different side without any face cover mask. Police party detained them at Bandwan Bus Stand under Bandwan PS. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to pandemic situation without face mask. As they refused to comply the direction given by govt. to combat Covid 19 pandemic and them committed negligent act likely to spread infection of diseased dangerous to life and violated Govt. rules which was promulgated by Govt. through public servants and through media etc. for prevention of attack, hence I arrested them for disobeying Govt. order vide No. 382-I.S.S./2M-24/2020, dtd-02/07/2020 of compulsory wearing of musk during this pandemic situation. I issued arrest memo and informed their ground of arrest as per section 3 of the epidemic diseases act, 1897, duly signed by the accused persons.
