As they refused to comply the direction given by govt. to combat Covid 19 pandemic and them committed negligent act likely to spread infection of diseased dangerous to life and violated Govt. rules which was promulgated by Govt. through public servants and through media etc. for prevention of attack, hence I arrested them for disobeying Govt. order vide No. 382-I.S.S./2M-24/2020, dtd-02/07/2020 of compulsory wearing of musk during this pandemic situation. I issued arrest memo and informed their ground of arrest as per section 3 of the epidemic diseases act, 1897, duly signed by the accused persons.
