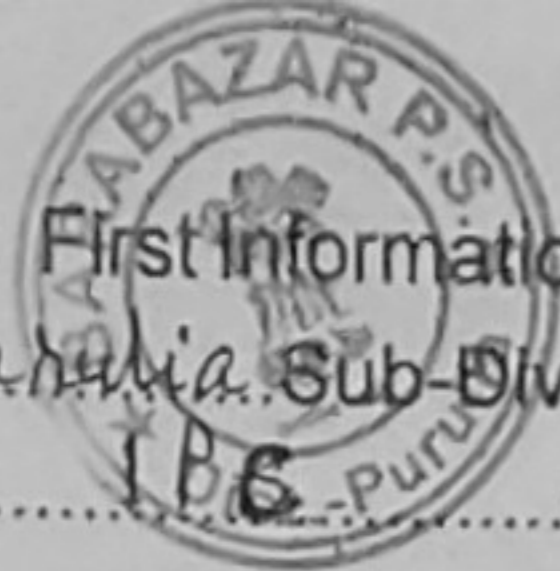

On arrival at Chwkbazar more under Barabazar PS at about 10.15 hrs. As such I requested the said persons to wear the face mask as a safety measure for themselves as well as others but they didn't pay any heed to my words and continued their unwanted activity of loitering inside the said Chawkbazar Market area without face mask. Find no alternative I detained them and asked them to disclose their identity. They disclosed their identity 1. Bidyapati Modak (42) S/O-Lt. On interrogation they failed to give any proper account/satisfactory reason for their being inside Chawkbazar market area and not wearing the face mask. I explained them the latest guidelines of Govt. like wearing of face mask mandatorily in public place in c/w the present ongoing pandemic situation due COVID 19 all around the world. But they behaved in such a manner that they do not care about the Govt. order. Thus they violated the order duly promulgated by Govt. through public servants and through media etc., for prevention of attack from CORONA virus/ COVID 19. Thereby they put the locals as well as themselves into risk of getting infected with CORONA virus and violated the order of DM, Purulia vide Memo no.189/Health dtd.25.09.20 which mandates the wearing of face cover in public places.

Accordingly, in between 11.15 to 11.45 hrs I arrested them for disobedience to order duly promulgated by public servant, after maintaining all the rules of arrest and issued memo of arrest. I informed them and their relatives regarding the ground of arrest.

On return to the PS I type this letter of complaint at our PS computer and submitted to IC Barabazar PS through duty officer SI Lakshmikanta Pati for taking necessary action as per law.
