
With due respect and humble submission I beg to submit that on 13.10.20 received a written information from one Rupchand Mandi S/O Muruli Mandi of village Tipudih, PO Barakadam, PS Boro, Dist. Purulia that he went to Shilda on 12.10.20 for some important work where he came to learn that his wife (Rajani Mandi) and son (Umul Mandi) was missing from home. After returning home he searched every possible places to find out them, but on the morning of 13.10.20 he found their dead bodies hanging from a tree beside their village. Over the death of Umul Mandi, Boro PS UD Case No. 27/2020 dated- 13.10.2020 was started and I have been endorsed to enquire the case.

During enquiry I have been to the village Tipudih and found the dead body of Umul Mandi was hanging from a "CHALLA" tree beside the village. I held inquest over the dead body and sent to Purulia Sadar Hospital Morgue for holding PM examination to ascertain the actual time and cause of death.

Today (02.11.2020) I received the PM report of deceased Umul Mandi in c/w Boro PS U/D Case No-27/2020 Dated.13.10.2020 and found that Dr. Shobhon Roy, Autopsy Surgeon opined that "death was due to the effect of the Ante mortem Strangulation by ligature, homicidal in manner".

I, therefore pray before you to start a specific case in this regard as the manner of death is homicidal, under proper section of law and to arrange for its investigation.


