
Sir,

In producing herewith one seized tractor bearing registration No-WB-55B-2321(Mahindra B275 DI) with trolley loaded with approx 100 cft sand as per seizure list. I SI Partha Sarathi Shit of Hura PS do hereby lodged a complaint against the owner and driver of the said seized tractor. The fact is that today i.e on 01/11/2020 at 18.05 hrs while myself along with force were engaged in night mobile duty at PS area received a source information from my reliable source that one tractor with trolley mentioned above was coming from Kansai riverside towards Daldali dih near Daldali village having loaded with sand without any royalty/challan. I informed the matter to O/C Hura PS and as per direction I SI Partha Sarathi Shit and force namely (1) C/1331 Kartik Rajwar (2) JC/1374 Sk Belal Ansary (3) HG/116 Janaki nath Mahato rushed to work out the source information . When we reached at Salbon near Daldali village at 18.35 hrs on village road from Hijuli to Daldali we found that one tractor with trolley coming towards Daldali village. We intercept the tractor loaded with sand.After seeing Police the driver of the tractor stop the tractor in a distance and driver able to flee away. We chased him but he able to flee away in the dark. Then I reached to the tractor and found that the trolley of that tractor is loaded with sand approx 100 Cft and none found with the said tractor. I searched the vehicle but neither any valid documents in respect of the loaded sand nor any documents of the said tractor could be found. I waiting some reasonable times but nobody turn up .It is learnt from the source that the owner and the driver of the tractor stolen away sand from kansai river bed in a clandestine manner and they are involved in illegal business for gain. As per order of ADM and DL & LRO, Purulia sand extraction from river bed is temporarily suspended as per order vide memo No VI/430(Part-VIII)/1247/M/17 Dated 03.07.2020. There is sufficient reasons to believ that the owner and driver of the said tractor is running clandestine business for wrongful gain with transportation of sand without any valid documents.Finding no other alternative I seized the tractor bearing registration No-WB-55B-2321 engine No-RKB 2EAN1254 Chassis No-MBNABAEXPKRB07013 with approx 100 Cft. sand loaded trolley after preparing proper seizure list duly signed by accompanied police persons because of unavailability of local people.


Therefore I request that a specific case may kindly be registered against the owner and driver of the said seized tractor bearing Reg. No.- WB-55B-2321 with trolley loaded with approx 100 cft sand, under proper section of law and arrange for its investigation.
