Sir,

I, SI Soumyadeep Mallick along with force return to PS and brought under seizure 01(One) seized Tractor- WB55A 7838 attached with a sand loaded trolley and lodged this complaint to the effect that today (06.11.2020) during evening mobile duty at about 17:25 hrs received a credible source information that some owners of the tractors were extracting sand illegally from Subarnarekha river at Basudih ghat. Accordingly, myself along with force left to work out the said source information. This refers to Jhalda PS GDE No-232 Dated- 06/11/2020 & Jhalda PS CC No- 3096 Dated- 06/11/2020. Then, we intercept the said vehicle at Jargo more on Jhalda Baghmundi road under Jhalda PS at about 18:45 hrs and found the above noted tractor was tagged with a trolley loaded with sand. But seeing the Police Party driver of Tractor and others fled away leaving his Tractor on road. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. So there is every reason to believe that the owner, driver and others of above noted Tractor dealing in sand business illegally and they do not have any proper challan or any documents related to the said loaded sand of above detained Tractor. So I, seized above noted Tractor having no WB55A 7838 with attached sand loaded Trolley (approx 100 cft).

On return to Jhalda P.S., kept the sand loaded seized vehicles at PS compound and I do here by submitting written complaint before you to start a cog case against owner and Driver of the Tractor having registration no WB55A 7838 & others under proper section of law.
