Sir,

With due respect I SI Susanta Kr Pathak of Joypur PS, beg to submit before you that on 07/11/2020 at about 06:35 hrs while myself along with force were performing day mobile duty at PS area and conducting raid against non-wearing of mask at Joypur Bazar on near RBB Football Ground on the side of Purulia-Ranchi road as per order of my superior vide Joypur PS GDE No-308 Date-07/11/2020 & CC No-5809/20 Date-07/11/2020 and found the following persons, were roaming at beside the RBB Football ground on Purulia-Ranchi road SH-4A without any face cover / mask. In spite of several request & reminder they refuse to wear mask and return back from public place to prevent the spread Covid-19 pandemic situation. I asked them to wear mask or leave the bazaar but they did not comply my request & roaming in the Bazar without face cover / mask. Myself along with accompanied force detained them at RBB Football ground they were coming from others villages for showing Mahila Football tournament on Purulia-Ranchi road SH-4A. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this respect DM Purulia promulgated an order for compulsory wearing of face cover / mask at Purulia District vide Memo No- 189/Health Dated-25/09/2020. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons arrested on 07/11/2020 from 16:15 hrs to 16:35 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.
