Sub: Prayer for lodging F.I.R. against arrested accused persons (1) Jatal Kumar (32Y) S/o- Mathan Kumar of Kokiara, PS-Joypur (2) Rajen Kumar (21Y) S/o-Bisheswar Kumar of Uparbatri, PS- Kotshia (3) Bhagbat Kumar (34Y) S/o-Gombhir Kumar of Uparbatri, PS-Kotshila all of Dist-Purulia

Sir,

With due respect I SI Milon Manna of Joypur PS, beg to submit before you that on 08/11/2020 at about 08:15 hrs while myself along with force were performing day mobile duty at PS area and conducting raid against non-wearing of mask at Joypur Bazar Atakol More on Purulia-Ranchi road as per order of my superior vide Joypur PS GDE No-385 Date-08/11/2020 & CC No-5827/20 Date-08/11/2020 and found the following persons, were roaming at Joypur Bazar Atakol More on Purulia -Ranchi road SH-4A without any face cover / mask. In spite of several request & reminder they refuse to wear mask and return back from public place to prevent the spread Covid-19 pandemic situation. I asked them to wear mask or leave the bazaar but they did not comply my request & roaming in the Bazar without face cover / mask. Myself along with accompanied force detained them at Joypur Bazar Atakol More they were coming from others villages. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this respect DM Purulia promulgated an order for compulsory wearing of face cover / mask at Purulia District vide Memo No- 189/Health Dated-25/09/2020. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons arrested on 08/11/2020 from 12:45 hrs to 12:55 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S -188/269/34 IPC & Read with section 51 of Disaster Management Act, 2005.
