In producing herewith one arrested accused person namely Golu Kumar Saw (19 yrs) S/o-Shankar Saw of 3A Thana More, Bokaro Steel City Sec-III Chas Bokaro, JKD under arrest along with seized articles as per seizer list i.e. 18 (Eighteen)) liters Id Liquor (CHOLAI) in a yellow colour Jarrican and one Tempu (Auto) having registration No-JH09AD5120 under proper seizure with label.

I ASI Jagannath Rakshit of Joypur PS hereby lodged a written complaint against the above noted accused person to the effect that today (02/11/2020) at about 13:05 hrs during my anticrime Naka checking duty at Kathaltard, as per source information myself along with C/-45 Samir Mahato, C/-969 Niranjan Mahato and C/-120 Sandip Kumar all of Joypur PS that one person namely Golu Kumar Saw S/o-Shankar Saw of 3A Thana More, Bokaro Steel City Sec-III Chas Bokaro, JKD was coming from Jharkhand side by driving one Tempu (Auto) having No-JH09AD5120 and carrying CHOLAI loaded in a Jarrican for the purpose of selling the same in Bartard side and detained him. I immediately informed the matter to IC of the PS and as per his direction and intercepted the above noted Tempu having No-JH09AD5120 and person, who was driving the same. On careful observation I noticed the registration no of the Tempu (Auto) is matched as per information. I searched the Tempu (Auto) and the person thoroughly and physically and on search found the above noted ID liquor (CHOLAI) loaded in a plastic jarrican. On demand he failed to produce any license / authority of the said liquor. He also failed to produce any paper in respect of the Tempu (Auto) as well as driving license. On interrogation he also made incoherent statement regarding possession of said liquor and told that he will sell the same in Bartard side upon the villagers illegally. So, finding no any other alternative I seized 18 (Eighteen)) liters Id Liquor (CHOLAI) in a yellow colour Jarrican above noted articles from the possession of the accused and labeled, duly singed by the accused person & witnesses in between 13:15 hrs and 13:35 hrs in which one bottle of ID liquor i.e. one bottle was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Golu Kumar Saw (19 yrs) S/o-Shankar Saw of 3A Thana More, Bokaro Steel City Sec-III Chas Bokaro, JKD U/S-46A (c) of the Bengal Excise Act 1909
