Sir,

With due respect I SI Dharanidhar Pande, beg to submit before you that on 11.11.2020 at about 16.15 hrs while I was on mobile duty, along with force C/2721 Saheb Chand and NVF/693 Jayanta Singh Sardar vide Kashipur P.S CC No 2729 Dt 11.11.2020 found following 06 (Six) persons, & 35/40 others unknown BJP, Kashipur Block Committee under the leadership of Swapan Chowdhury, Jayanta Goswami & other leaders and supporters organized a unlawful assembly at Kashipur Bazar followed by a procession from Rajbari More to Kashipur Traffic More under Kashipur PS area with BJP party flag and posters without any permission even they did not maintain physical distancing nor they used masks or any kind of mask related safety gears in this pandemic situation of COVID-19 to spread the virus which is dangerous to human life. They detained Kashipur Traffic More. On being asked the following BJP leaders and supporters could not able to give any satisfactory answer for that unlawful assembly and procession.. The name of the BJP leaders and supporters are (1) Swapan Chowdhury S/O Lt Aswini Chowdhury of Near Water tank Kashipur, P.S Kashipur, Dist Purulia (2) Jayanta Goswami S/O Sunil Goswami of Dhanera, P.S Kashipur, Dist Purulia (3) Shyamapada Mahato S/O Arjun Mahato of Narayangar, P.S Kashipur, Dist Purulia (4) Krishna Mahato S/O Amulya Mahato of Siulibari, P.S Kashipur, Dist Purulia (5) Chanchal Halder S/O Samir Halder of Gourangdih, P.S Kashipur, Dist Purulia (6) Rajesh Garain S/O Durgadas Garain of Kashipur Namopara, P.S Kashipur, Dist Purulia & 35/40 other unknown leaders/supporters.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 143/188/269/270 IPC read with section 51 in the National Disaster Management Act, 2005 & 32 Police Act.
