Gourangdih, Dist - Purulia at about 8:00 P.M. today
(03/11/20) in front of my house (in front of
Talatjuri P.H.C). He suddenly attacked my family
members with some sharp weapon during
the incident. When I protested, he assaulted me
with fist and blows and with his sharp
weapon. We are assuming this was rapped
due to some old family issues. Fortunately,
As a result, I received injuries on my person
and treated on nearby hospital. Fortunately,
local villagers came during the incident and helped
us to get rid of the situation.

person.
