- 2) That the petitioner and his co-sharer have owner of the bari land of mouza Hirapur, R.S. plot no. 552 and cultivating the same as seasonal crops/vegetables therein.
- 3) That on the date time of occurrence i.e. 21/06/2020 the petitioner is working his vegetable land at that time of occurrence Chandi Charan Kuiry used fealthy Language to petitioner and such away Kodal (Spread) from the hand of the petitioner and assulted to Rampada Mahato forcibly by Lathi on his head intension of Chandi charan Kuiry was to commit murder, as a result the petitioner feldown and bleeding injury.
- 4) That souted and on hearing of the petitioner one Haraprasad Mahato reached to the p.o. then Fatik Kuiry, Rabi Kuiry and chakrahar Kuiry and Jaydeb Kuiry all of Begunkodar came to the spot all of them armed with Sabal, Kural and Lathi .
- 5) That Fatik Kuiry assulted Haraprasad Mahato on his forehead by Sabal and in consequence of such assult Hara-prasad feldown then Fatik Kuiry and Jaydeb Kuiry intension to commit murder caught hold the neck-up Fatik and Jaydeb Kuiry and also threatend that they will burried Fatik and Jaydeb Kuiry.

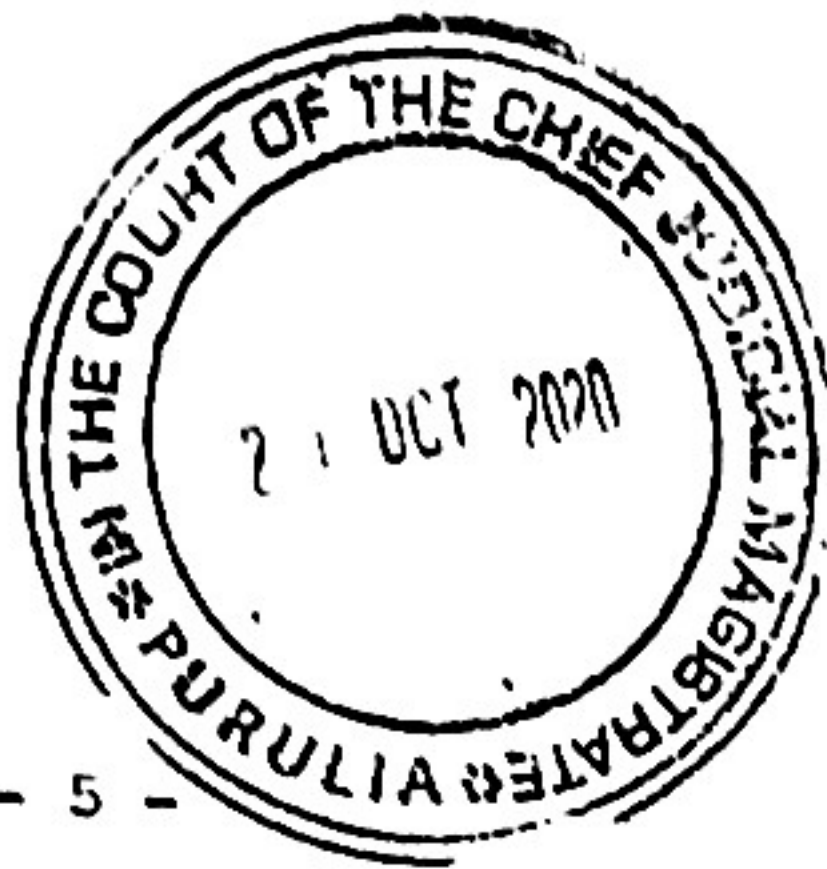

- 6) That also some villagers of Hirapur i.e. Sanatan Mahato, Basanta Mahat O Basna, Rashbihari Mahato Ranglal Mahato and others have reached the p.o. the aforesaid accused persons assaulted to Sanatan Mahato and Basna Mahato by lathi and Sabal and as a result they also sustained injury.
- 7) That when maximum persons of village Hirapur came to the spot of their souted and hearing the accused persons fled away from the spot.
- 8) That immediate the injured persons managed to treatment Kotshila Rural Hospital but condition of serious Haraprasad Mahato refer to better treatment.
- 9) That the petitioner inform the matter to the O/c Kotshila P.S. But the concerned P.S. not taken any step above incident and so the petitioner subsequently on 12/10/2020 have filed the said complaint petition before the superintendent of Police Purulia by regd. Post A/D but the police superintendent also did not take any action till today and as such file the present petition before your Honour's Court.
