Sir,

In producing here with one accused person Fatik Sing Sardar (30) S/O Lelu Sing Sardar of village Gopalpur PS Manbazar District Purulia along with following seized articles viz-

- (1) 25 (Twenty five) Ltrs ID liquor within a Jarikane
- (2) 08 pieces plastic glass
- (3) 200 M.L. ID liquor collect from the Jarikane as sample

I S.I. Soumen Kumar Panda of Manbazar PS do here by lodged a complaint against accused namely Fatik Sing Sardar (30) S/O Lelu Sing Sardar of village Gopalpur PS Manbazar District Purulia to the effect that today (09.11.20) at 16:15 hrs. I received a telephonic information from a reliable source that one Fatik Sing Sardar (30) S/O Lelu Sing Sardar of village Gopalpur PS Manbazar District Purulia was stocked ID liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 346 Dtd 09.11.20. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/496 Prakash Ch Mahato & C/1184 Subhendu Maity rushed to the spot for raid by Govt. vehicle. At about 20:15 hrs. myself along with force reached at Gopalpur village and held raid in the house of Fatik Sing Sardar and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Fatik Sing Sardar tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Fatik Sing Sardar (30) S/O Lelu Sing Sardar of village Gopalpur PS Manbazar District Purulia as per law and arrange for its investigation.
