Sir,

This is to inform you - I, Sri Avijit Sen, husband of Bijoya Sen, permanent resident of Vill. Madhupur, P.S. Manbazar, District Purulia, at present residing at ABC Township, Qtr. No. LRM74, Durgapur, my wife and Krishna Sen purchased properties in Mouza Madhupur and the property used to look after by me at the time of cultivation and harvesting season. I along with my elder-brother's wife and my wife, Bijoya Sen used to visit the village on 16/10/2020 to harvest paddy, as there was a Civil case is pending against the persons named below, they out of grudge restrained me to harvest the paddy and accordingly I had been to local P.S. and explained the situation. They assured me that there will be no breach of peace and my wife and Krishna Sen preferred an application U/S 144 Cr.P. Code before the LG. Sub-Divisional Executive Magistrate, Purulia, which has been registered as Misc. Case No. 932/2020, where the notice has been served upon the police. On 22nd day of October, 2020, while I was harvesting paddy Prabir Sen, Pranab Sen, sons of Late Rabindra Nath Sen, Bibek Bishal Sen, son of Pratab Sen of Vill. Madhupur at about 11.00 a.m. suddenly attacked me with lathi, and started assaulting me and I sustained injury on my right arm and my chest and started shouting that BACHAW BACHAW they will murder me.
