Sir.

I, SI Sujoy Kundu of Neturia PS, Dist- Purulia do hereby lodge a written complaint against Bablu Mondal (48 Years) S/O- Lt. Kalipada Mondal of Vill-Benipur, PS-Neturia, Dist-Purulia to the effect that today on 07. 11.2020 while I along with C/1224 Gajan Murmu, C/382 Bipad Taran Chatterjee and C/1140 Dayamoy Mahato all of Neturia PS as per order were engaged in mobile duty in Neturia PS area vide Neturia PS GDE No- 307 dated 07.11.2020 and CC No. 3059/20 for implementation of Government rules regarding Disaster Management Plan and while we reached at Jhanka More under Neturia PS at about 17: 35 hrs found that the above noted person was selling goods in his Hotel at Jhanka More to the customers without wearing mask which violates the compliance of norms of Government order during this pandemic situation. I took photograph him and asked him non-wearing of mask during this pandemic situation COVID-19 while he was selling goods to the customers but he failed to give any satisfactory answer. I would like to note here that on seeing police party all the customers left the place quickly. So, he violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188 IPC & 51 (1) (b) of National Disaster Management Act, 2005. I interrogated him and during interrogation he disclosed his identity noted above. After interrogation I arrested the above noted accused person by maintaining all formalities regarding arrest as he committed cognizable offence in presence of police U/S-188 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and informed ground of arrest.

So, there is every reason to believe that the above noted person was selling goods to the customers without wearing mask by violating the Government order during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life.

Therefore, I pray a specific case may kindly be started against accused Bablu Mondal (48 Years) S/O- Lt. Kalipada Mondal of Vill-Benipur, PS-Neturia, Dist- Purulia U/S- 188 IPC and 51 (1) (b) of National Disaster Management Act, 2005 as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
