Sir.

In producing herewith one seized Truck bearing No -WB 51B/4165 loaded with steam (raw) coal approx 03 M.T. do hereby lodge a complaint against the driver of vehicle No- WB 51B/4165, owner of vehicle No- WB 51B/4165 and owner of seized coal from the vehicle No-WB 51B/4165 to the effect that in the night of 01/02.11.2020, I, SI Bablu Ghosh along with (1) C/1304 Dhananjoy Mondal (2) C/1303 Biswanath Majhi and (3) C/1260 Santosh Saren all of Neturia PS were engaged anticrime night mobile duty in PS area and Naka checking at D. Ghat vide Neturia PS GDE No- 36 Dt. 01.11.2020 and CC No- 2996/20 Dt. 01.11.2020. while we were engaged in Naka checking duty at D. Ghat at about 04:05 hrs (02.11.2020) found one truck was coming from Barakar side and on seeing police party the driver of the said truck fled away after leaving the truck about 50/60 meter away from Naka place (D. Ghat). We chased to apprehend the driver of the vehicle but in spite of hot chase he managed to flee away. Then we searched the vehicle and found that the vehicle (Truck) bearing No - WB 51B/4165 has been loaded with steam (raw) coal approx 03 M.T.

So, there is reason to believe that the driver, owner of coal and registered owner of the said vehicle have collected the said coal either by theft or by any fraudulent means and tried to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Accordingly I seized the said truck bearing no - WB 51B/4165 loaded with steam (raw) coal of approx 03 M.T. under proper seizure list duly signed by the Police witnesses, since no public witness was found as well as collected approx 05 kg steam (raw) coal from the above noted seized truck as sample and sealed & labeled the same. I also arranged to keep the vehicle loaded with at PS compound.

Under the above fact & circumstances a specific case may kindly be started against the (1) driver of truck bearing registration No - WB 51B/4165 (2) Registered owner of truck bearing registration No - WB 51B/4165 and (3) (2) owner of the coal, seized from truck bearing registration No - WB 51B/4165 under proper section of law.
