with all due respect I, ROUSTAV CHOWDHURY,
son of GIRANDA CHOWDHURY, resident of Kataran Professor
colony in Purulia Town, wants to draw your attention towards
the incident that took place on 8th of November 2020,
around 3 PM in the afternoon when I was visiting one
of my plot which is located near to the DUBRA HIGH School,
having the holding plot number as 2952 in DUBRA, attacked
brutally by KARPIK CHOWDHURY, son of LATE BHANU CHOWDHURY,
along with his wife, son and daughter namely PROMILA
CHOWDHURY, SOUMEN CHOWDHURY (BAPP), MOHUA CHOWDHURY
(BABY) respectively with wooden blocks and a Iron Rod
by virtue of which I felled down and broken my left
hand by the hit of Iron Rod. The above namely mentioned

or so when I regain my sense, I managed to take myself
to the near PARA HOSPITAL for first-aid and after that
I was advised and get admitted into Purulia Sadar
HOSPITAL for the treatment of my broken hand. I managed
anyhow and got the required treatment and running under
medicines now and at the same time my parents are too
old to ~~better about~~ get disturbed.

Therefore, I request your highness to please
lodge a case against the four namely culprits and
prevail the Justice which I am seeking for.
