Sub: Complain for road blocked

Sir,

l ASI Anil Chandra Gorain of Purulia (M) PS, Dist-Purulia do hereby lodge a suo moto complain after arriving at PS in respect of that today 12.11.2020 I along with force was performing mobile duty at PS area vide Purulia (M) PS GDE No-489 dtd-12.11.2020 and in consonance of the Purulia (M) CC No-2994/2020 dtd-12.11.2020 received a telephonic information from duty officer of Purulia (M) PS regarding road blocked at Gengara more on Purulia-Bankura road (NH-60A) and the road was obstructed by the supporters of BJP party over the issue of the onslaughts on their District President at Alipurduar. Immediately after receiving the information I along with force rushed to the spot after being instructed by you with Govt. vehicle WB56C/0018 at about 17.15 hrs. As soon as I arrived at the spot, I found that the road has been blocked by the 100 supporters of BJP party with the help of Traffic guard rail, and mustering themselves by displaying their Party flag in the middle of the National Highway after forming un-law full assembly under the leadership of (i) Rakhakar Pandey of Bhangra (ii) Subarna Pathak of Upor Surulia (iii) Doctor Mahato of Nadiha (iv) Sukumar Bauri of Bhangra (v) Manik Bauri of Raghabpur (vi) Partha Sarathi Gorain of Gengara (vii) Prabhas Rajak of Gengara (viii) Bappa Das of Gengara, (ix) Asish Mahato of Gengara (x) Bishnu Mahato of Dabar (xi) Krittibas Mahato of Bhangra (xii) Styabrata Das of Hutmura (xiii) Adhir Choudhury of Hutmura (xiv) Kajal Roy of Bhangra all of PS-Purulia (M), Dist-Purulia. Subsequently I saw some of the villagers under the leadership of Rakhakar Pandey threatened the drivers of the vehicle with dire consequences by lathi if they tried to move the vehicles. The vehicular traffic was totally disrupted and seized along the Purulia-Bankura road (NH 60A). I talked with the leaders to with draw the blocked but they paid no heed to my words and they continued their blocked. Thereafter, I informed the matter to you. Despite of all I persuaded further and tried to convince the supporters as well as the leaders that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal. I along with force started to disperse them form the road but the road blockers obstructed us adamantly from the discharge of our public functions. Latter after the prolonged discussion the mob withdrew the blocked at 17.35 hrs and they blocked the road incessantly for 55 hrs approx. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the supporters of the BJP Party committed offence u/s 143/186/283/506 IPC & 18 W.B Highway act. 1964 under the leadership of supra noted persons ergo, I submitted suo moto complain before your good self to started specific case against them.
