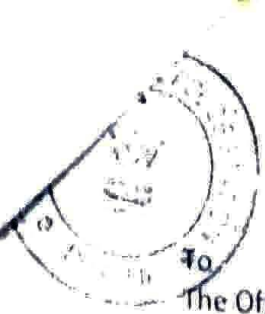

With due decorum, I would like to inform you that Shri Baldesh Bauri, S/o- Shri Nitya Bauri, Vill- Surulia (Bauridi), P.O- V.Nagar, PS.- Purulia (M), Dist.- Purulia, W.B. came at the gate of Surulia Mini Zoo, Purulia at about 1:00 PM on 24/11/2020 in inebriated condition. He intended to extort money from the cash counter. Then Shri Prakash Singh, Animal Attended of the Surulia Mini Zoo tried to forbid him from committing any misdeed but Baldesh Bauri began to hurl abuses and beat Prakash Singh.
