With due respect and humble submission I beg to state that I am Matahir Sekh (28) S/o Safik Sekh of Kolagara, PS Raghunathpur, Dist-Purulia.


I beg to inform you that on 03/11/2020 at about 19:15 hrs while my brother namely Sekh Rakesh (24 Years) S/o Safik Sekh of Kolagara, PS Raghunathpur, Dist-Purulia was returning to his home at Kolagara by riding on a bicycle from Raghunathpur side and when he reached near to Krishnapur More on Para-Raghunathpur Pitch Road one Motorcycle having Registration No WB82D/2390 which was coming from same direction hit him from back side, as a result he fell down on the ground and received bleeding injuries on his persons and immediately shifted to Raghunathpur SS Hospital, wherefrom he was shifted to RIMS Ranchi for his better treatment. On 09/11/2020 my brother expired at RIMS Ranchi during treatment. Over this one UD Case was registered at Baritu PS, Dist-Ranchi vide No. Ist PIR -12826 & 2nd PIR 13049 dated 09/11/2020. This only happened due to rush and negligent driving by the driver of the offending Motorcycle having Registration No. WB82D/2390. The bicycle was also damaged for this accident.

So, I therefore, pray before you kindly take necessary legal action against the driver of the offending Motorcycle having Registration No. WB82D/2390 and also seized the said motorcycle.

Due to treatment of my brother and for his funeral ceremony I failed to submit complain in time.
